NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-II/FINAL PHASE OF COUNSELING TO FILL THE VACANT MANAGEMENT QUOTA SEATS IN POST GRADUATE DENTAL DEGREE/DIPLOMA COURSES IN PRIVATE DENTAL COLLEGES IN THE STATE OF ANDHRA PRADESH FOR THE ACADEMIC YEAR 2021-22.

In continuation to earlier Notification, the University hereby notifies the following schedule for **PHASE-II/FINAL PHASE** of Web counselling to fill up vacant seats under Management Quota (i.e., Unfilled seats after Phase-I, vacancies due to not reported and also the vacancies that may arise due to sliding of candidates during the process of this final Phase) of PG Dental Degree/Diploma courses in Private Non-Minority Dental Colleges in the State of Andhra Pradesh:

All the candidates whose names are in the Final Merit Position under MQ seats already displayed in the University Website are eligible for exercising web options.

INSTRUCTIONS TO THE CANDIDATES

1. Those candidates who were allotted a seat in the Phase-I and joined in the allotted seat are also eligible to exercise web options as per the above schedule, for sliding to any Specialty/College as per their choice.
2. The seats unfilled in the Phase-I of counseling, vacancies due to non-reporting of the candidates selected in the Phase-I of counseling and resultant vacancies if any arise due to sliding of candidates during the process of this Phase of counseling will also be filled simultaneously. The vacancy position will be displayed in the University website.
3. **Candidates who have already joined in All India Quota Counseling in any State and for the seats in Deemed Universities are not eligible to exercise web-options. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.**
4. **Those candidates who were allotted a seat in the Phases-I (MQ) but not reported in the allotted seat are not eligible for this Phase-II (MQ) counselling.**
5. If any candidate who has been allotted a seat but not reported in this Phase-II of counselling will not be permitted to participate in the MOP UP Round. Candidates who have joined in this Phase-II are also not eligible to participate in MOP UP Round.
6. The candidates who joined in the Phase-I of counselling and wish to change their College/Course according to their Merit, can exercise their web options. Candidates are informed that, once PG seat is allotted in this Phase of counseling as per their web options, the seat allotted in the earlier Phase-I of counselling will be automatically cancelled and re-allotted to other candidate in this phase.

7. A candidate can exercise options for any number of specialties irrespective of the number of vacancies. Candidates are advised to be careful while exercising options on the Web and take the print out of the saved options.
8. Candidates are advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies shown in seat matrix. Candidates are advised to give options to the courses for which they are really interested to join, so as to give chance to next meritorious candidates.
9. Candidate can download the provisional allotment order on payment of University fee of Rs.49,500/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order failing which the candidate will lose the admission. Candidates who have already paid the University fee in Phase-I need not pay again.
10. Candidates who have joined in any college of AP in Phase-I of MQ seats/Competent Authority Quota seats but slid to another college in this Phase-II should submit the tuition fee receipt along with relief letter and Custodian Certificate issued by earlier college, for admission at the newly allotted college. The first college where the candidate initially joined will transfer the tuition fee to the newly allotted college/return to the candidate and issue relief letter & Custodian Certificate by e-mail to the Candidate and Principal of the newly allotted college.
11. Candidates who have joined either in Phase-I or in this final phase should not withdraw from the seat from now onwards under any circumstances.

“As per G.O. Ms. No. 67 of HM&FW (C1) Dept., Govt. of Andhra Pradesh, dt: 21-04-2017, a candidate who exercised options and joined in the allotted seat shall not be permitted to withdraw from the seat and in case if any candidate withdraws from the seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3 lakhs + 18% GST (i.e., Rs.3,54,000/-)”.

12. The University fee once paid shall not be refunded under any circumstances.
