Instructions to the candidates for PG Dental Courses for this MOP UP Round:

1. Candidates allotted and joined any seat in Management Quota (MQ) counselling are **not eligible**.
2. Candidates allotted and joined any seat in Competent Authority Quota (CQ) counselling are **not eligible**.
3. Candidates who have been allotted any seat in Phase-I, Phase-II & MOP UP of CQ counselling (or) any Phase (I & II) of MQ counselling are **not eligible** to exercise web options for this MoP UP round.
4. Candidates who have discontinued/withdrawn the course after joining in any Phase of CQ (or) MQ are **not eligible**.
5. Candidates who have joined any course in ALL INDIA QUOTA / DEEMED UNIVERSITIES counselings are not eligible for MOP UP Round. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.
6. **IMPORTANT NOTE:** Candidates if allotted any seat in this MOP UP Round should compulsorily join the course and they will not be permitted to withdraw from the course under any circumstances. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.
7. Vacancy position i.e., Un-filled and Not reported seats will be displayed in the University website.

Candidate can download the provisional allotment order on payment of University fee of Rs.49,500/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order failing which the candidate will lose the admission.
