1. I am to inform you that as per the Exams Schedule fixed for the year 2021, the next MDS Part-II Exams are to be conducted in **May, 2021**.
2. I am, therefore, to inform you that the students who are admitted in the year **2018-19 batch** and who are appearing for MDS Part-II Exams in **May, 2021** and who have not submitted dissertations earlier are to submit Dissertation in One Soft Copy (CD) **with 01 (one) PDF File** to the University as per the dates mentioned below for sending to the External Examiners for Evaluation. The following is the fee.
 3. A) Dissertation fee Rs.3, 000/-
B) The last date for receipt of the Dissertations **:26.02.2021**
 4. The fee is to be paid in the form of a crossed DD from any Nationalized Bank, in favour of **“THE REGISTRAR, Dr.NTR UNIVERSITY OF HEALTH SCIENCES, PAYABLE AT VIJAYAWADA”**. A consolidated DD may also be sent by the Principal, for convenience.
 5. The students are informed to submit Two more copies of the Dissertations at their concerned colleges which are to be retained by the respective HOD’s/College Offices for Evaluation by the concerned Internal Examiners.
 6. The approval of Dissertation shall be a precondition for the candidates eligibility to appear for the final examination.

Hence, the candidates whose dissertations are not approved by the examiners will not be allowed for the examination.
