The amount towards Examination fee and Marks Memo fee of all the candidates of your College should be sent in a Consolidated **Demand Draft drawn in favour of Registrar, Dr. NTR UHS payable at Vijayawada**, alongwith the detailed information in a statement i.e. No. of subjects appearing by each candidate, Examination Fee & Marks Memo fee paid by each candidate.

**The eligibility to appear for there exams are:**

1. The MPT students who took admission into the colleges in A.P. and whose admission is approved by the University during the academic year 2019-20 or prior and who have completed one(01) year duration of the course shall appear for the 1<sup>st</sup> MPT Examinations December, 2020.
2. Candidates who are having 80% of attendance in each academic year are only eligible to apply for the Examinations. Candidates who are not having the 80% of attendance are NOT eligible to write the Examination.
3. The candidates whose dissertations are approved only are eligible to appear for final MPT Examinations December, 2020. Hall tickets will not be issued to the candidates whose dissertations are NOT approved.

**Candidates appearing for both 1<sup>st</sup> year & 2<sup>nd</sup> year MPT course prior to 2018-19 batch shall submit ICR forms separately for 1<sup>st</sup> & 2<sup>nd</sup> year MPT supplied by the University.**

**The Digital Valuation of answer scripts has been already implemented from May/June, 2019 Examinations onwards for Medical and Dental PG Degree / Diploma course. The same Digital Valuation was implemented in MPT Examinations from October/November, 2019 onwards.**

**In view of introduction of Digital Valuation of MPT answer scripts a single 68 pages OMR answer book with 64 writable pages will be issued to the candidates. The candidates should answer all the questions in the single answer book of 64 writable pages only.**

I also request you that the following details shall be furnished to the undersigned well in advance:

1. The list candidates appearing for the Examination.
2. Bio-data of the teaching staff who are teaching the subjects in the respective institution to consider the Examinership (Internal Examiners). Subjectswise Examiners list for 1<sup>st</sup> MPT & 2<sup>nd</sup> MPT should be furnished in the prescribed proforma given by the University only. For 1<sup>st</sup> year MPT Exams Principal should specify 2 Examiners names in each subject Physiotherapeutic – I & Physiotherapeutic – II.
3. Advance and stationery requirements for conduct of MPT Examination should be furnished alongwith a detailed statement showing the approximate expenditure to be incurred.

4. Subject wise periodic test marks of all eligible regular and referred candidates should be furnished.
5. Attendance particulars and periodic test marks of all exam going students should be furnished separately with separate covering letters.

Kindly arrange to check the applications whether they are in Order / all columns are filled by the students with required information and send them to the University with your Counter signature on the applications.

Please also furnish the number of Practical answer books and required stock of Practical answer books available and advance amount required, in the enclosed proforma. If previous advance is not settled, fresh advance will not be sanctioned.

**Further , it is to inform that the I MPT Examination to the students of Colleges in Telangana State in respect of 2016-17 admitted batch onwards will be conducted by Dr.Kaloji Narayana Rao University of Health Sciences, Warangal. Therefore, notification and other related guidelines will be issued by the said University only. However, Dr. NTR University of Health Sciences , Vijayawada will continue to conduct Ist and Final Year MPT Examinations in respect of referred candidates of MPT course who are admitted prior to 2016-17 batch.**
