NOTICE TO THE CANDIDATES FOR THE WEB BASED COUNSELING FOR ADMISSION INTO
MBBS COURSE UNDER COMPETENT AUTHORITY QUOTA SEATS OF SPORTS & GAMES
CATEGORY FOR THE ACADEMIC YEAR 2022-23

In continuation to this office notification, dated.05.11.2022, it is hereby notified the following in connection with web based counseling for admission into MBBS course under Competent Authority Quota seats of Sports & Games category for the academic year 2022-23 for information of the candidates who have exercised one time options.

1. The details of seats available for Sports & Games category of counseling:-

2. Candidates eligible for Sports & Games counseling (As per the one-time options already exercised).
- Candidates present in the final merit list of Sports & Games category display in the University website on 21.12.2022.
 - As per the orders dated.22.07.2022 of the Hon'ble Supreme Court of India in Contempt Petition (C) No.289 of 2022 and as per the Notice 12021/01/2022-MEC, dt.12-07-2022 of DGHS, HM&FW Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards. The allotted candidates of Phase-I, Phase-II & Mop-up rounds of counseling are not eligible to upgrade in Special Category counseling of Sports & Games quota.
 - Candidates who have exercised onetime options but could not get seat allotment in earlier phases of counselling.
3. The selections will be made strictly as per the G.O.Rt.No.550, dated.30.07.2001 as amended vide G.O.Rt.No.111, dated.13.08.2019 and G.O.Rt.No.159, Higher Education (E.C) Department, Dated.13.11.2020.
4. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website:<https://ugcq.ntruhsadmissions.com> for status of allotment.
5. All the allotted candidates in this phase shall compulsorily join in the seat.

6. The University fee once paid shall not be refunded under any circumstances.
7. Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee of Rs.10,600/- along with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
8. Verification of original certificates will be conducted at the college during admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University regulations.
9. Pay the tuition fee to complete the admission process, failing which, the candidate's admission will be cancelled.
- 10.No candidate is permitted to withdraw from the course till closure of admissions.
- 11.Decision of Competent Authority is final.
