In continuation to this office notification dated 03-02-2023&09-02-2023 Dr.YSR UHS Vijayawada hereby notifies the schedule for exercising web options for Phase-II of Web based counselling for admissions into Management Quota seats in Private Un-aided Non-Minority Homoeopathy Medical colleges for the academic year 2022-23.

All the candidates whose names are in the Final Merit Position Management Quota displayed on 09-02-2023 in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the Website <http://drntruhs.in>

**UNIVERSITY FEE:** The selected Candidates have to download the allotment order by pay Rs.20,100/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the order and pay the prescribed tuition fee at college.

**TUITION FEE FOR UG AYUSH COURSES:** The selected candidates have to pay tuition fee of Rs.3,00,000/- per year for admission into Management Quota seats in Private UG AYUSH (BHMS) Courses in Un-aided, Non-Minority UG AYUSH Colleges as per orders of Government of Andhra Pradesh G.O.Ms.No.159 HM& FW (C2) Dept., dt.23.12.2020 & G.O.Ms.No.14 HM& FW (C1) Dept., dt.09.02.2021.

Note: Ministry of AYUSH, NCISM, New Delhi has not granted permission to Sri Adi Siva Sadguru Ali Saheb Sivaaryula Ayurvedic Medical college & Research Centre, Guntakal for the academic year 2022-23. Hence, this college is not included for Competent Authority Quota Counselling as per the orders of Hon'ble High Court of A.P. in I.A.No.1/2022 in W.P.No.41459/2022, dated 24.01.2023.

**Instructions regarding web options and allotment of seat:**

1. Candidates who have joined All India Quota seats under Govt./Govt. Aided/CU/NI/ Deemed Universities and are not allowed to participate in counselling for admission to UG (BAMS/BUMS/BHMS) courses under State Quota/UT Quota/Institutional Quota/ Central pool Quota/AIQ (Private Institute) etc. for the academic year 2022-23 as notified vide Lr.No.14030/85/2022-EP-1, dt.02-02-2023 of AACCC, Ministry of AYUSH, New Delhi.
2. Reported candidates who have not opted to free exit from AIQ Private un-aided Non-Minority UG AYUSH (BHMS) Colleges are not eligible to participate in this counselling.

3. The following are the vacancies available for MQ Phase-II:

4. Eligible candidates should exercise web options for Management Quota seats in all Private Un-aided Non-Minority Homoeopathy Medical colleges in AP along with application.
5. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of web options schedule.
6. Candidates are instructed to be careful while exercising options on the web.
7. No further notification for exercising web options will be issued.
8. Based on the merit list and order of priority of colleges, allotment letters will be released to the candidates, if seat is allotted.
9. The candidate who secured admission in the Phase-I of counselling and wish to change their college/course according to their merit, can exercise their web options. Candidates informed that once BHMS seat is allotted in this phase of counselling as per their web options, the seat allotted in the Phase-I of counselling is automatically cancelled and Re-allotted to other candidates in this Phase-II.
10. Candidates while giving options should note the seats vacated by the candidates selected in previous counselling and slide to other college/course during this phase of counselling process will be added & allotted simultaneously during the phase of counselling itself.
11. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the **website:** <https://ugayushmq.ntruhsadmissions.com> for status of allotment.
12. Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II, but should download the allotment order if there is a change in Phase-II.
13. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
14. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
15. Candidates are informed that verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
