Application forms are invited afresh for filling up of stray vacancies in PG (Medical) Courses for the academic year 2022-23 from the candidates who have qualified in NEET PG-2022 and **not applied earlier to the University and also not admitted in any Medical Colleges** for the Academic Year 2022-23.
