INSTRUCTIONS

Note: One time Web options exercised by the candidates for this MoP Up Round will also be considered for further additional MoP Up Rounds if any conducted by Dr.YSR UHS for Management Quota seats.

1. Eligible **Non-Service candidates** whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates and according to the Seat Matrix displayed in the University Website <http://ntruhs.ap.nic.in>.
2. Candidates who have not been allotted any seat in any Phase-I/Phase-II of Management Quota counselling **are eligible** to exercise web options for PG Dental Courses.

Not eligible candidates for web options for this MoP Up Round:

- 1) Candidates who have been allotted any seat in Management Quota (MQ) of AP State are **not eligible**.
- 2) Candidates joined any seat in State Quota (SQ)/Competent Authority Quota of AP State are **not eligible**.
- 3) Candidates who have joined any seat in All India Quota /Any State/Deemed Universities (Including KNR UHS, TS) counselling are not eligible for this MOP UP Round. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.
- 4) **IMPORTANT NOTE: Candidates if allotted any seat in this MOP UP Round should compulsorily join the course and they will not be permitted to withdraw from the course under any circumstances, as it comes under intentional blocking of seats. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.**

5) **Note: Withdrawals/Resignations from joined seats will not be permitted under any circumstances.**

6) Candidate can download the provisional allotment order on payment of University fee of Rs.49,600/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order failing which the candidate will lose the admission. Candidates who have already paid the University fee need not pay again.

7) The University fee once paid shall not be refunded under any circumstances.

8) **TUITION FEE FOR PG Dental:** The following is the **Tuition fee structure** to be payable for the Management Quota seats in Private Un-aided Non-minority Medical Colleges as per GO.Ms.No.56, HM & FW (C1) Department, dated 29-05-2020 of Government of Andhra Pradesh:

Note:1) The fee structure in Private Unaided Non-Minority Colleges is as per G.O.Ms.No.56, HM&FW (C1) Dept., Dt.29-05.2020 as per the directions of the Hon'ble High Court in W.P.No.10159 of 2020 and batch, dt.09-07-2020, which is read as "to permit the petitioners/students to pay fee fixed by the Regulatory authority by executing bond in the proforma prescribed by the Andhra Pradesh Private Medical and Dental Colleges Managements Association within the specified time as notified by Dr. NTR University of Health Sciences, Vijayawada".

2) As per the directions of Hon'ble High Court in W.P.No.21389 of 2021, dt.01-10-2021 "to pay the stipend being paid by the Dental colleges under G.O.Ms.No.75 Health, Medical and Family Welfare (C1) Department, dated 06-05-2017 pending further orders".

9) As per Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi OCI/PIO/Foreign Nationals will only be eligible for NRI seats and not for Indian (All India Quota/Central/Deemed paid (Indian) seats for the current academic year. For complete details refer Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi.

- If it is found at a later stage that, the candidate has concealed any information, legal action that deems fit as per Rules will be initiated without any intimation.
- Necessary undertaking to this effect shall be submitted at the allotted college where required verification will be carried out by the Principal concerned.
